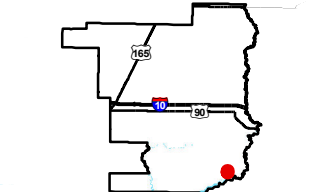
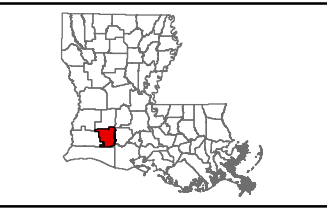
Key Site Points:
