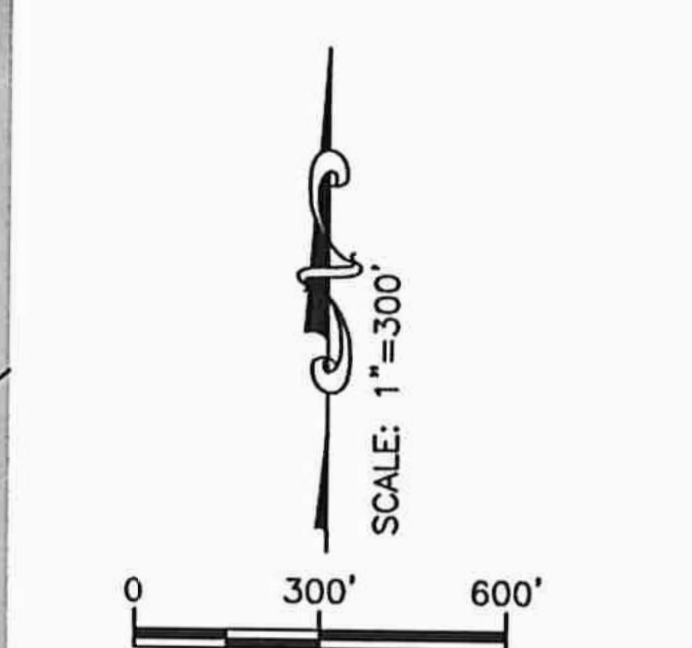


VICINITY MAP
