

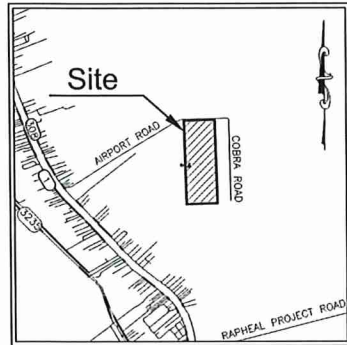

South Lafourche Airport South Site Property Boundary Aerial Exhibit

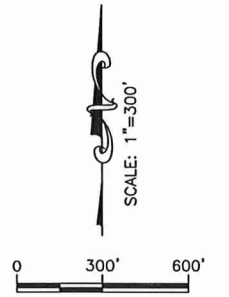
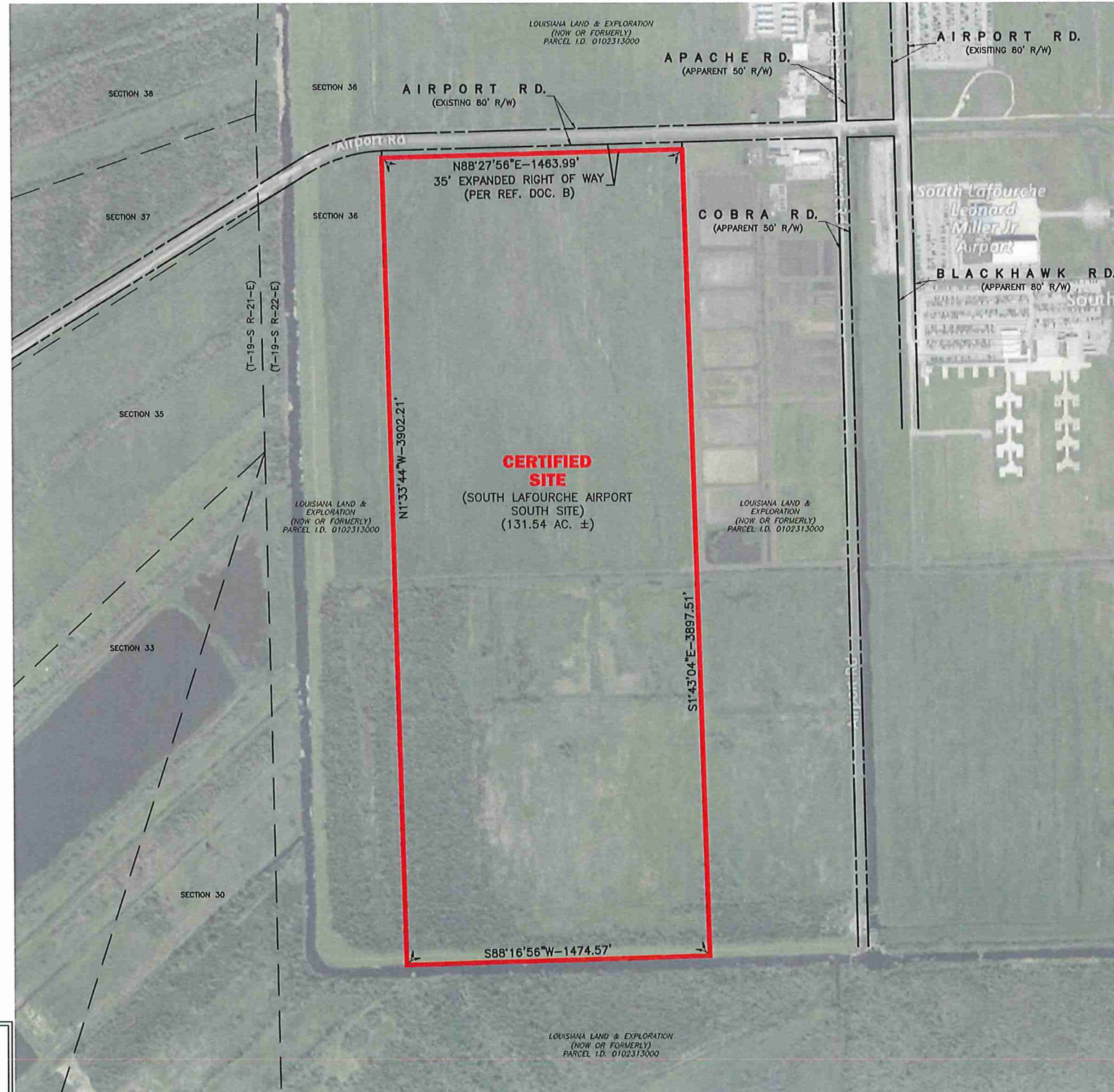

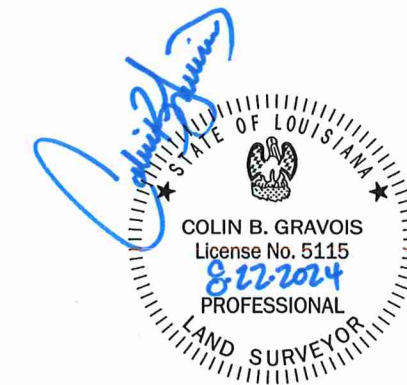
