According to the FEMA Digital Flood Insurance Rate Map (DFIRM) panel no. 22047C0355D and 22047C0365D of Iberville Parish, Louisiana, effective November 6, 2013, the Belle Grove property is located in two flood zones. Approximately 30.19 acres north of the levee are located in Flood Zone "AE", with the remaining 536.35 acres south of the levee are located in Flood Zone "X". The LiDAR contours downloaded from LSU's ATLAS site indicate that the site ranges in elevation from 14 feet to 28 feet, however, the mean elevation of the developable property on the site is at elevation 17 feet.

The 30.19 acres north of the levee in Flood Zone AE are located in the Mississippi River batture and are not developable. Therefore, no further action is needed to meet floodplain construction standards.


