BE IT REMEMBERED, THAT WE the undersigned, for and in consideration of the sum of One Dollar, paid, receipt of which is hereby acknowledged, and other good and valuable consideration, have given and granted, and do by these presents give and grant unto the SOUTHWESTERN ELECTRIC POWER COMPANY, its successors and assigns a corporation, herein referred to as Grantee, the right to set and maintain the anchor (s) and down guy (s) to support one or more electric line poles on OUR land in CADDO Parish, Louisiana, described as follows:

On the John S. Welsh, Jr., et al tract, designated 11 on assessors plat book,

located in the E/2 of Section 21, T17N, R15W, Caddo Parish, Louisiana.

The approximate location of said anchor (s) and down guy (s) being outlined in red on plat attached hereto for more certainty of description.

WITH THE RIGHT to place said anchor (s) and guy (s), and shall be in perpetuity. The Grantee is further granted the right to go upon said lands for the purpose of making all necessary repairs, alterations or removal of said guys and anchors under this grant.

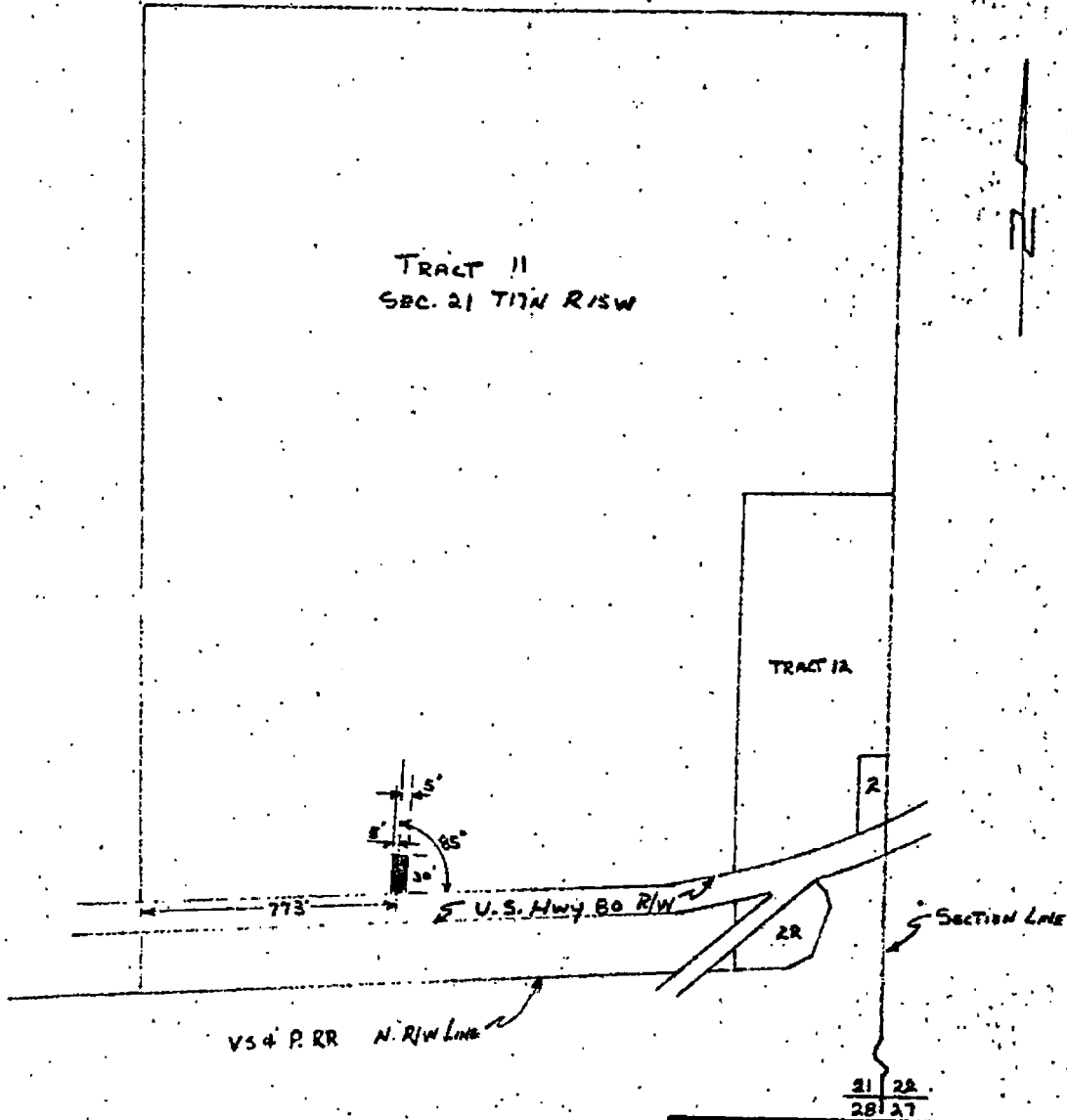
