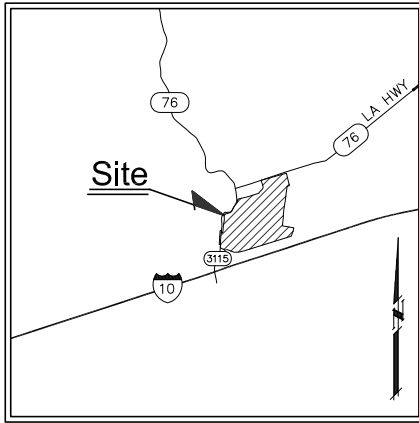


# Exhibit G. Grace Farms East Property Rights of Way Survey

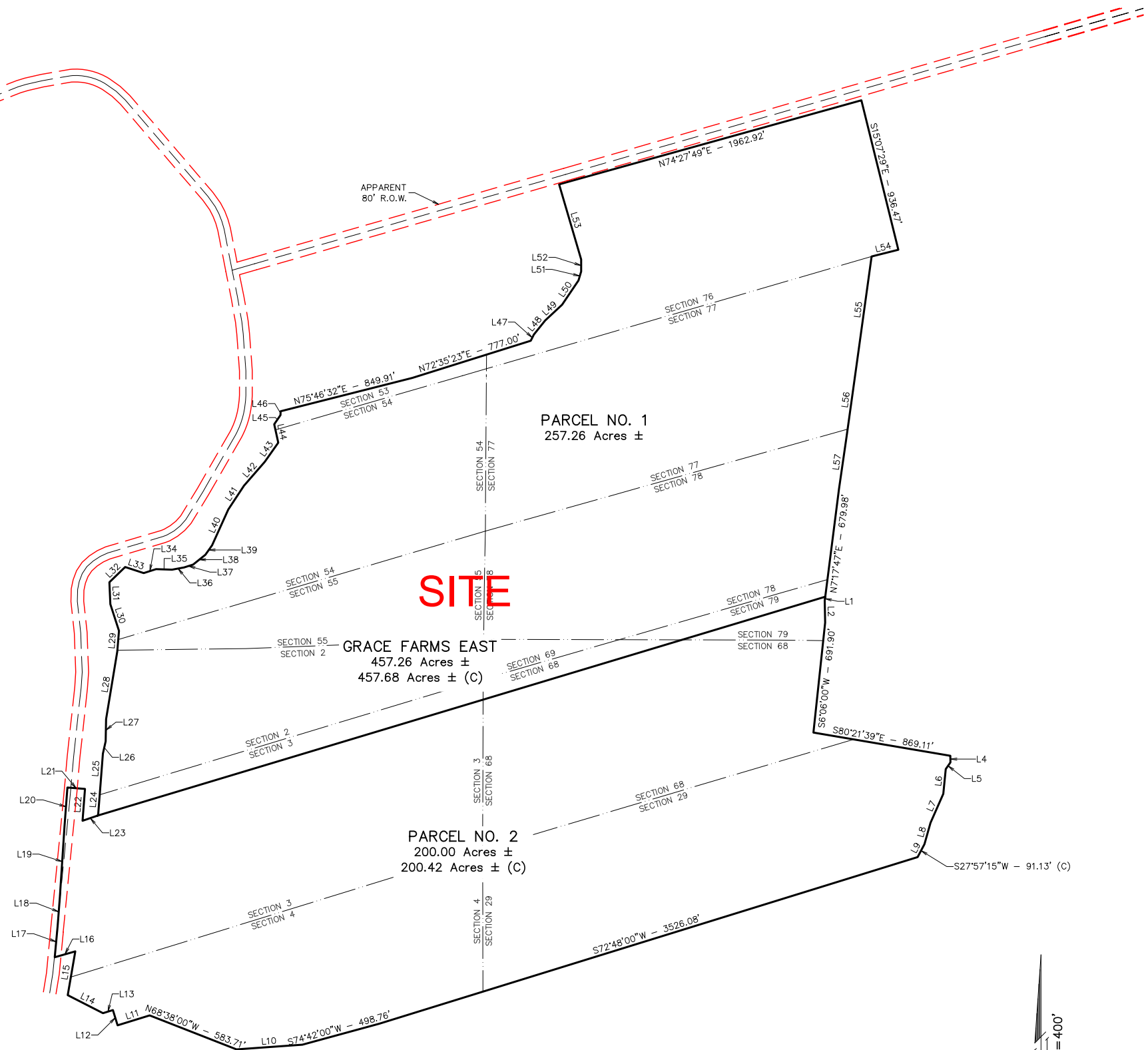


VICINITY MAP
