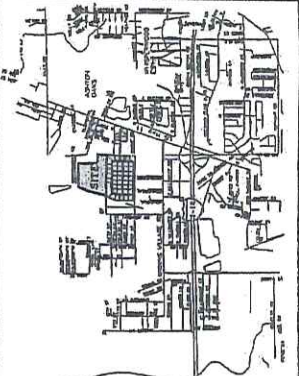
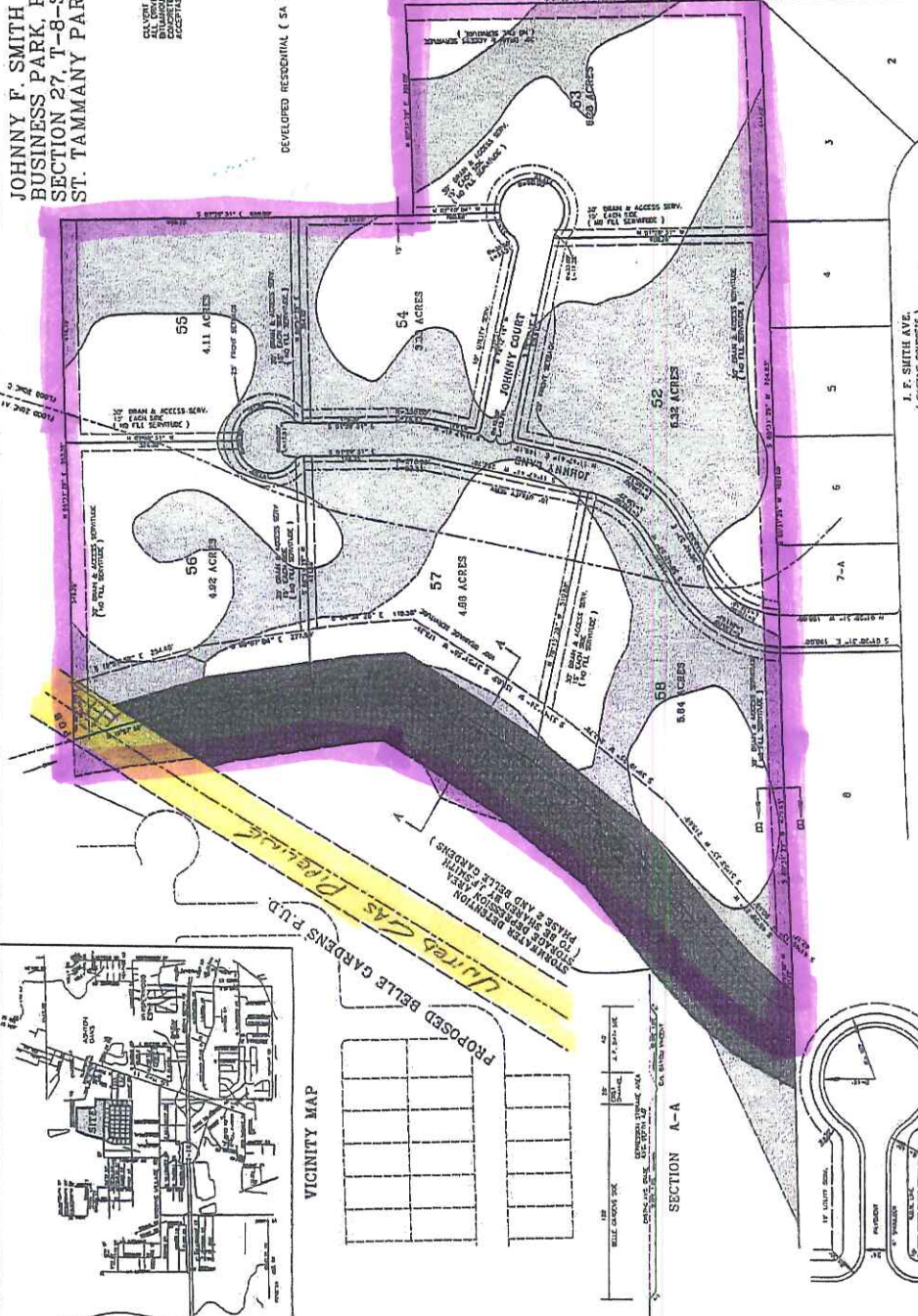


Exhibit #10 - Johnny F. Smith Business Park - United Gas (Boardwalk) Pipeline ROW
